

# MEMORANDUM OF AGREEMENT

**KNOW ALL MEN BY THESE PRESENTS:**

The **MAPÚA INSTITUTE OF TECHNOLOGY**, an educational institution duly recognized and existing under and by virtue of Philippine laws with principal office at Muralla St., Intramuros, Manila, herein represented by its President, **DR. REYNALDO B. VEA**, heretofore duly authorized and hereinafter referred to as "**MAPÚA**";

and

**Barangay 833, Pandacan, Manila**, a Local Government unit existing under the laws of the Republic of the Philippines, herein represented by its Barangay Chairman, **HON. EMILIA C. ENRIQUEZ**, herein referred to as "**BARANGAY 833**";

**WITNESSETH, that:**


**WHEREAS, BARANGAY 833** expressed the need for technical and knowledge-based learning institutions in the country in its various projects;

**WHEREAS,** part of **MAPÚA**'s mission is to extend community and technical extension services to and build linkages with government and industry;


**WHEREAS, MAPÚA** has made known its intension to provide necessary technical expertise and know-how available in Mapúa in undertaking different projects proposed by either Mapúa or the barangay and approved by Mapúa for the benefit of the environment and general welfare of the residents of **BARANGAY 833**;

NOW THEREFORE, for and in consideration of the above premises and the covenant herein set forth, the parties have agreed on the following:

1. THAT in no case shall **BARANGAY 833** be obliged to give financial support to the project in carrying out its duties and obligations set forth in this covenant;
2. THAT the data gathered and analyzed will be jointly owned by the institutions represented;
3. THAT **MAPÚA** will subsequently enter into several Memorandum of Agreement or Letter of Agreement with other government agencies, NGOs or companies, whenever necessary to achieve the objectives of the project;
4. THAT **BARANGAY 833** will continue to ensure that the research and projects are relevant and responsive to the needs of **BARANGAY 833**.



6. That in case of amendments and/or revisions of any portion of this agreement, it shall be upon mutual consent of the parties and in writing. Rescission or revocation of this agreement shall be presented to the parties in writing at least fifteen (15) days from notice to the other party.
7. That this AGREEMENT shall be in force and binding between the parties during the term of incumbent Chairman to commence from execution hereof, renewable for a like period upon agreement of the parties, unless earlier terminated by either of the parties upon written notice to the other party.


