**Barangay 845, Pandacan, Manila**, a Local Government unit existing under the laws of the Republic of the Philippines, herein represented by its Barangay Chairman, **HON. JOVITA T. SALVADOR**, herein referred to as "**BARANGAY 845**";

### WITNESSETH, that:


**WHEREAS, BARANGAY 845** expressed the need for technical and knowledge-based learning institutions in the country in its various projects;


**WHEREAS**, part of **MAPÚA**'s mission is to extend community and technical extension services to and build linkages with government and industry;



NOW THEREFORE, for and in consideration of the above premises and the covenant herein set forth, the parties have agreed on the following:

1. THAT in no case shall **BARANGAY 845** be obliged to give financial support to the project in carrying out its duties and obligations set forth in this covenant;
2. THAT the data gathered and analyzed will be jointly owned by the institutions represented;
3. THAT **MAPÚA** will subsequently enter into several Memorandum of Agreement or Letter of Agreement with other government agencies, NGOs or companies, whenever necessary to achieve the objectives of the project;
4. THAT **BARANGAY 845** will continue to ensure that the research and projects are relevant and responsive to the needs of **BARANGAY 845**.

7. That this AGREEMENT shall be in force and binding between the parties during the term of incumbent Chairman to commence from execution hereof, renewable for a like period upon agreement of the parties, unless earlier terminated by either of the parties upon written notice to the other party.






