

MEMORANDUM OF AGREEMENT

KNOW ALL MEN BY THESE PRESENTS:

This Memorandum of Agreement is made and executed by and between the **MAPÚA UNIVERSITY** with address at Muralla St, Intramuros, Manila, 1002 Metro Manila represented by, **DR. REYNALDO B. VEA**, and herein referred to as the **FIRST PARTY**.

-AND-

OSPITAL NG MAYNILA MEDICAL CENTER, a legally incorporated hospital, with address at **QUIRINO AVENUE, MALATE, MANILA**, represented by **DR. KARL OLIVER B. LAQUI** OIC – MEDICAL DIRECTOR, herein referred to as **SECOND PARTY**.

WITNESSETH:

- a. That dependence on the paid blood donation system through commercial blood bank has unduly exposed the Filipino people to such dreaded diseases such as malaria, hepatitis B and C and other transfusion transmissible disease;
- b. That the best way to prevent further contagion of the above blood transmissible diseases is through voluntary blood donation.

WHEREAS both PARTIES envision helping the Department of Health institutionalize voluntary blood donation in the country by setting up voluntary blood donation activities in coordination with churches, government and non – government organizations;

WHEREAS both PARTIES believe that collaboration and cooperation between government and non-government organization are effective strategies toward the promotion of people's health;

WHEREAS both PARTIES believe the country's colleges; universities, business establishment and civic organizations are potential sources of blood and active disseminators of the benefits of voluntary blood donations;

NOW THEREFORE in consideration of the foregoing premises and the mutual promises and agreement contained herein, the PARTIES hereto, intending to be legally bound to one.

1. The project subject of this Memorandum of Agreement shall be known as the Voluntary Blood Donation Program at MAPUA UNIVERSITY.
2. The parties will hold blood donation activities on such date, time, and place agreed by them.
